

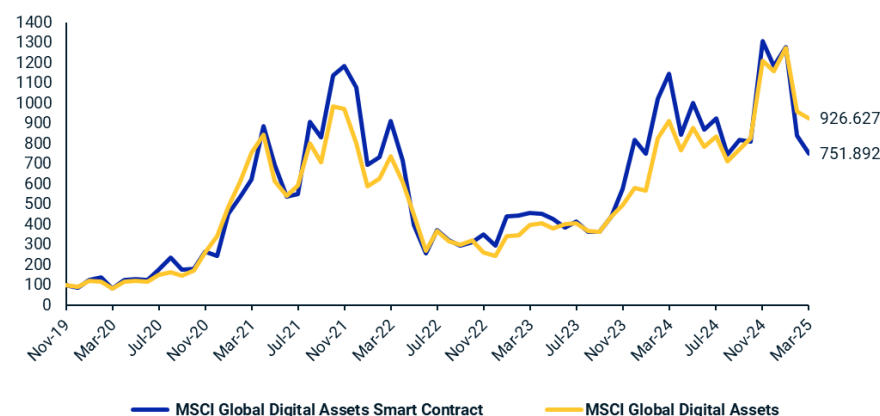
# MSCI Global Digital Assets Smart Contract Index
